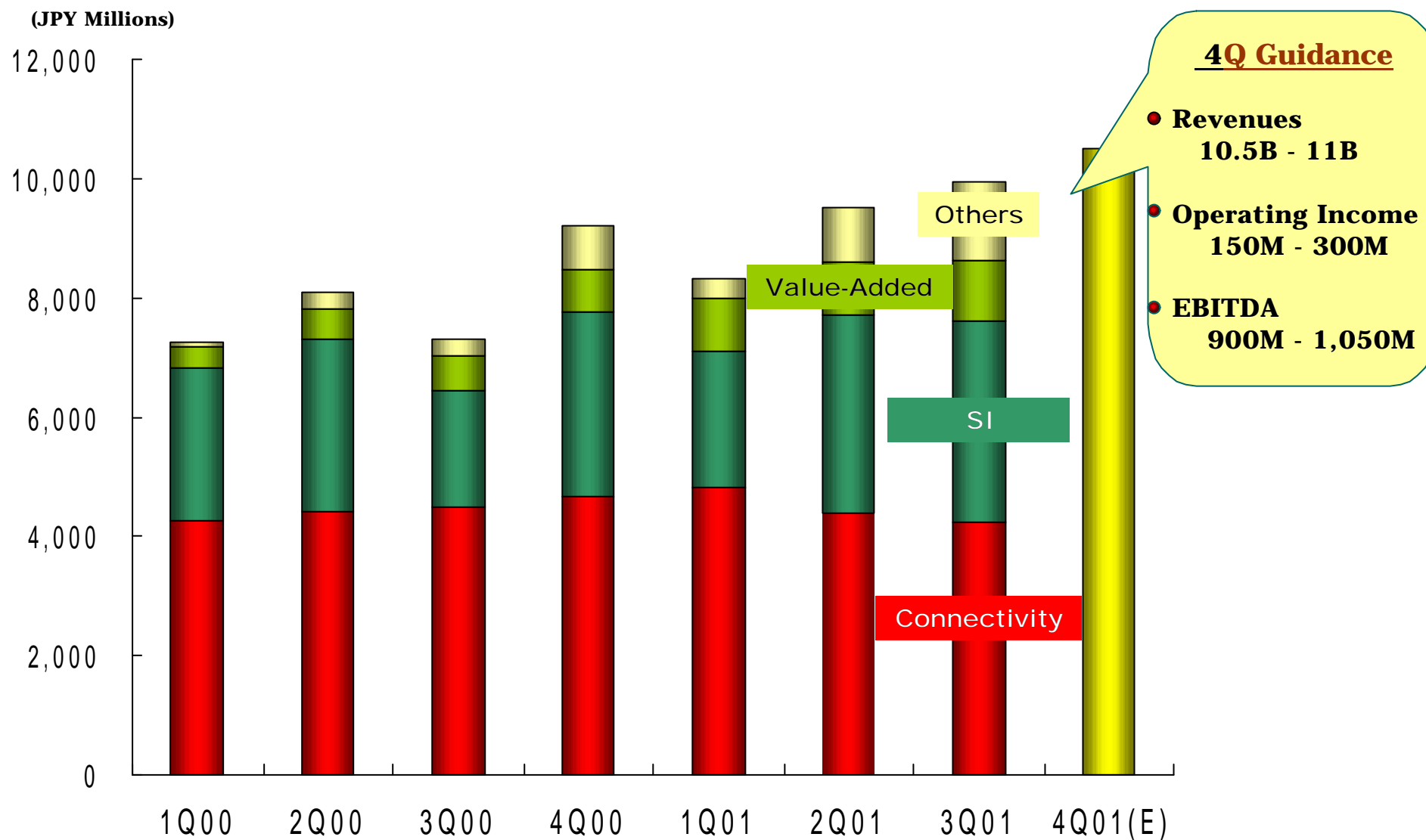

Highlights in the 3Q Results

- **Steady Growth in Total Revenues**
 - JPY9.9 billion, grew by 35.7% from 3Q00 and by 4.3% from 2Q01.
- **Continuous Decrease in International Backbone Cost**
 - Decreased by 62.4% from 3Q00 and by 14.0% from 1Q01.
- **Steady Improvement in Operating Performance**
 - Gross margin increased to 14.7%, from 6.7% in 3Q00 and from 14.1% in 2Q01.
 - Operating income continued to improve to JPY151 million
 - EBITDA continued to improve to JPY904 million
- **Expecting Further growth in 4Q01**
 - Top line to be JPY10.5-11.0 billion, grow by 14.1-19.6% from 4Q00.
 - Operating income to be JPY150 million - JPY300 million, EBITDA to be JPY900 million - JPY1,050 million
- **Expecting 20% growth for Full fiscal 2001**
 - Top line to be JPY38.3 billion - JPY38.8 billion
 - Operating income to be JPY18 million - JPY168 million
 - EBITDA to be JPY2,893 million to JPY3,043 million

Revenues Breakdown (Quarter Basis)

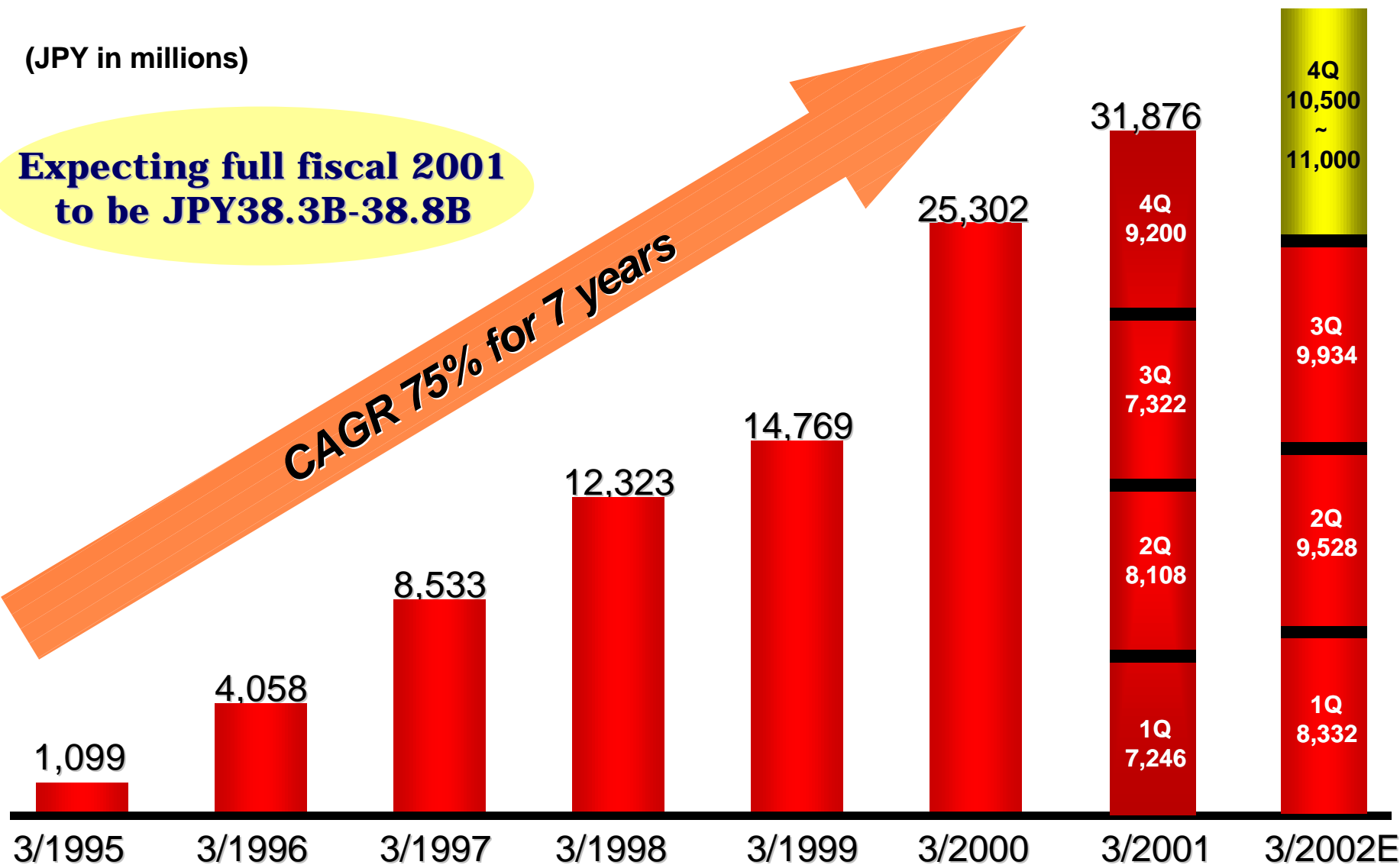


IIJ Consolidated Revenues

(JPY in millions)

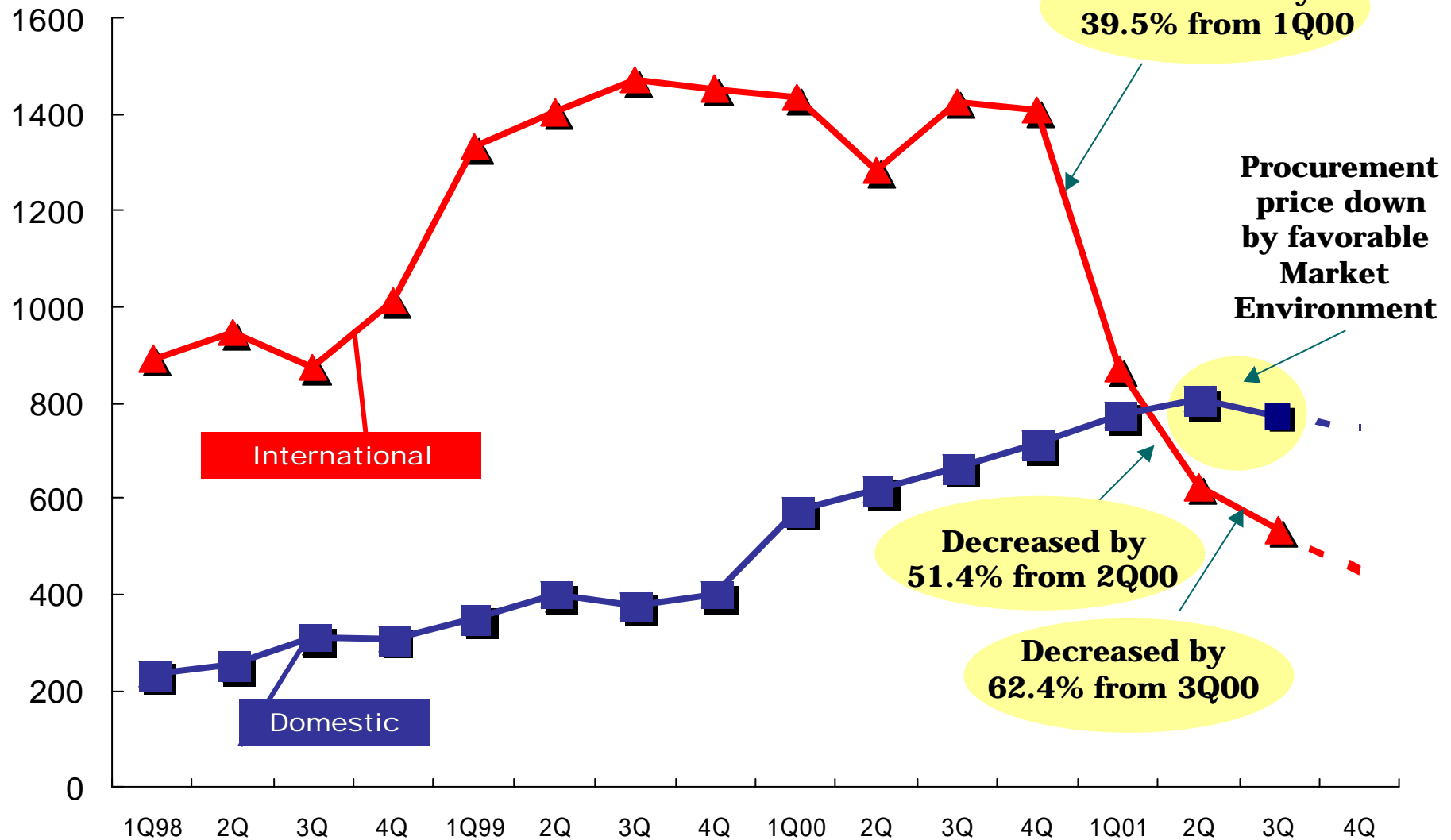

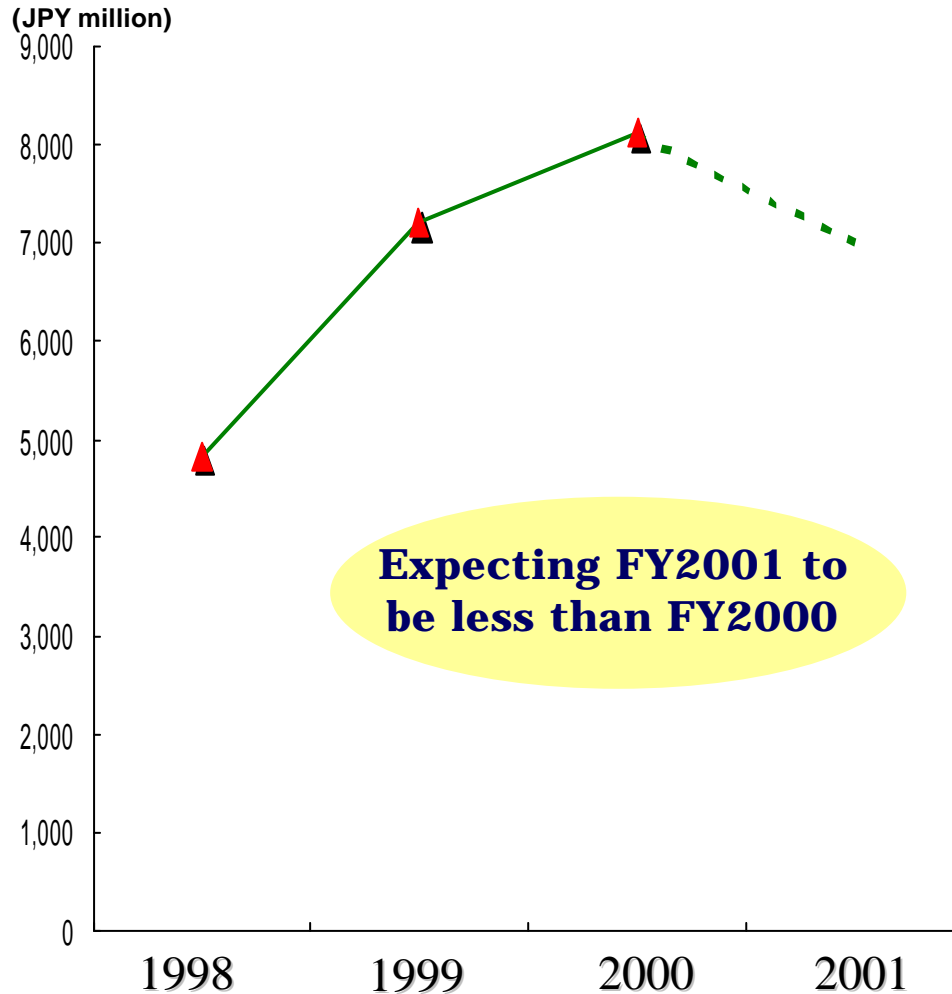
Backbone Costs (1)

(JPY Millions)

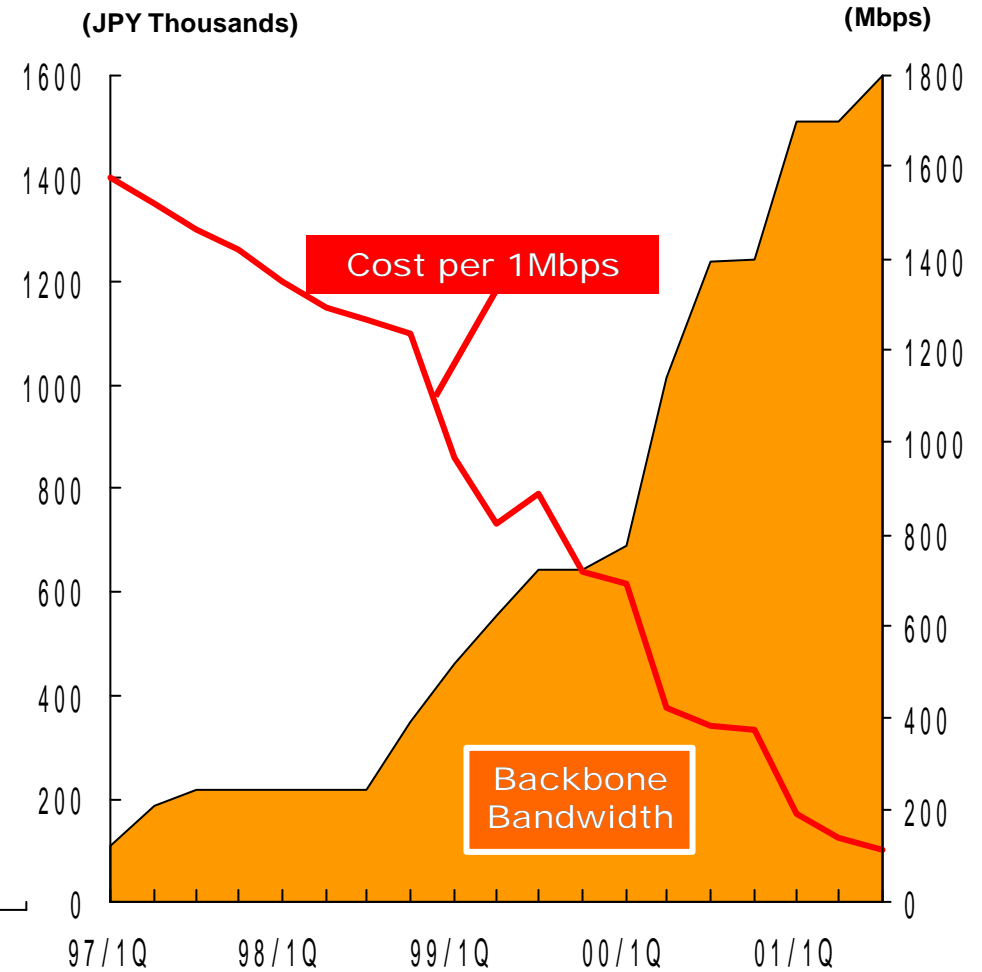


Backbone Costs (2)

Domestic & International BB Costs

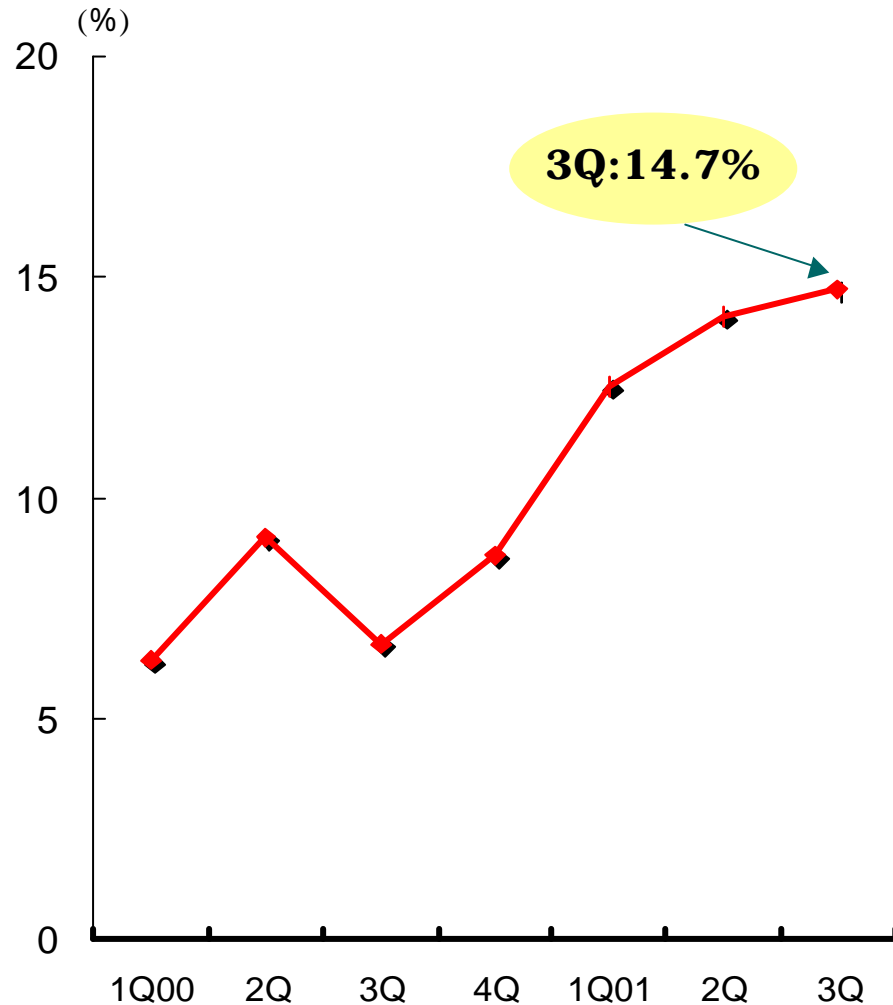


Unit Price for International BB

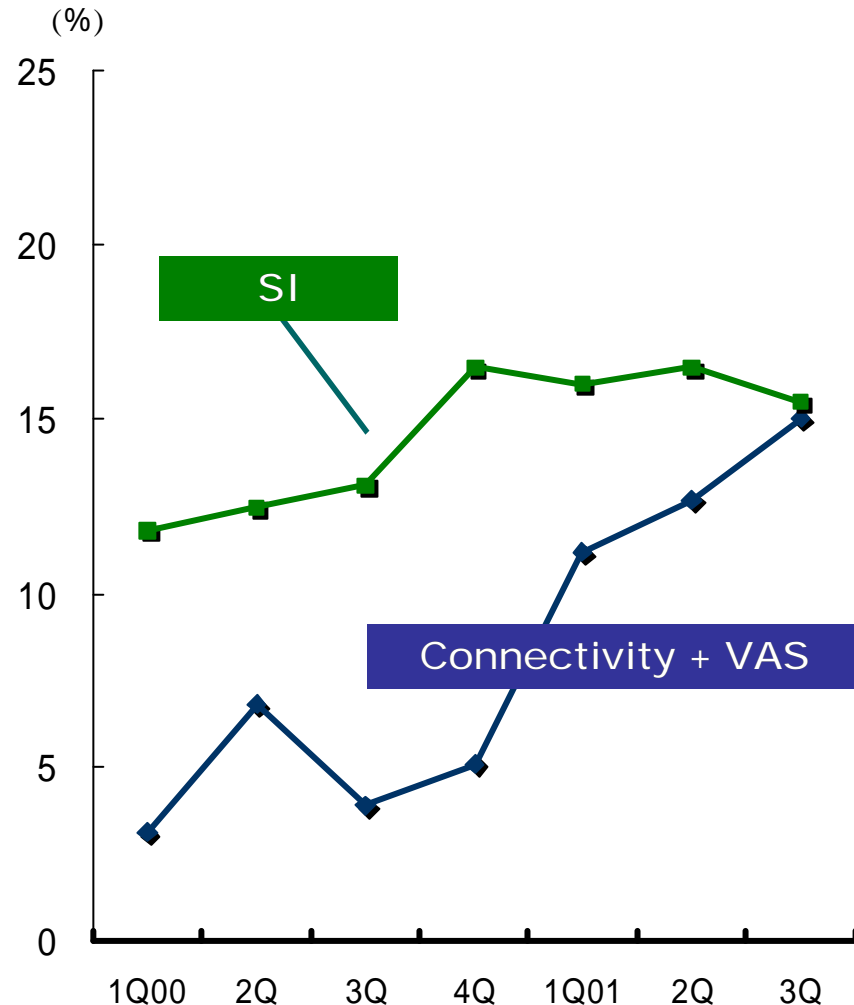

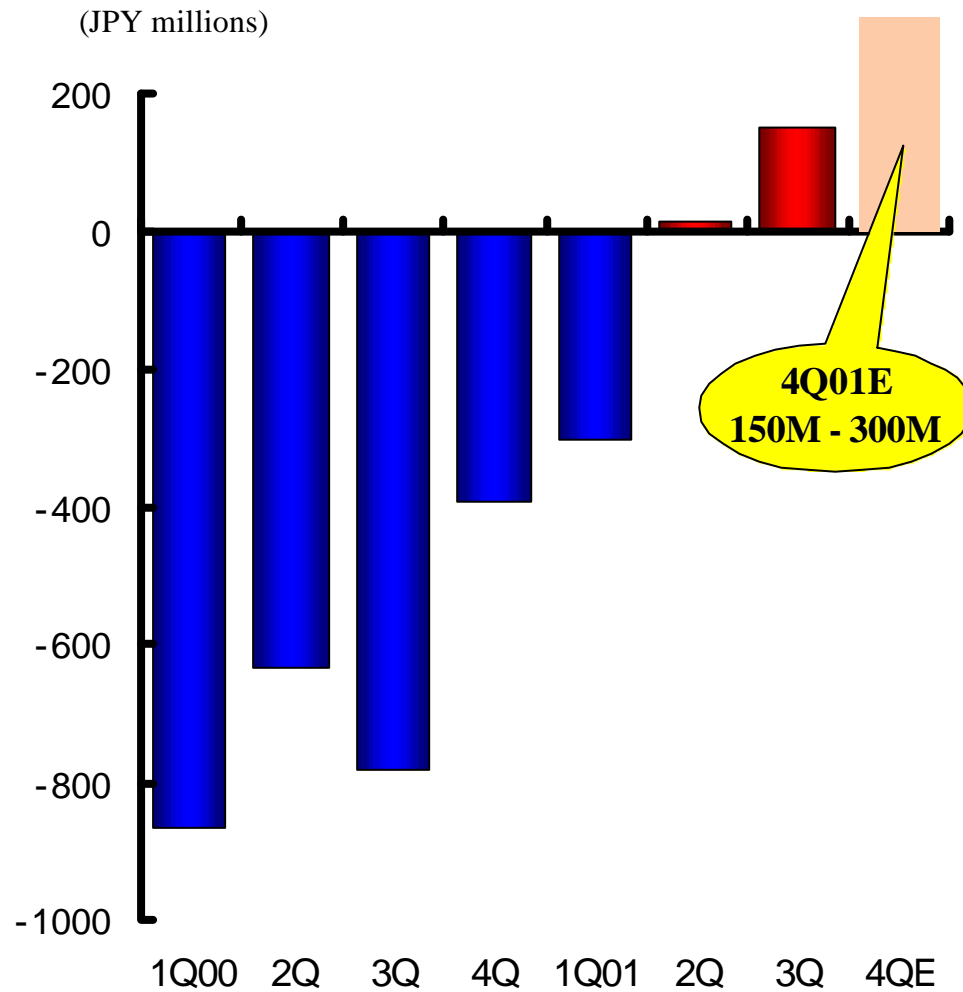


Gross Margin By Segment

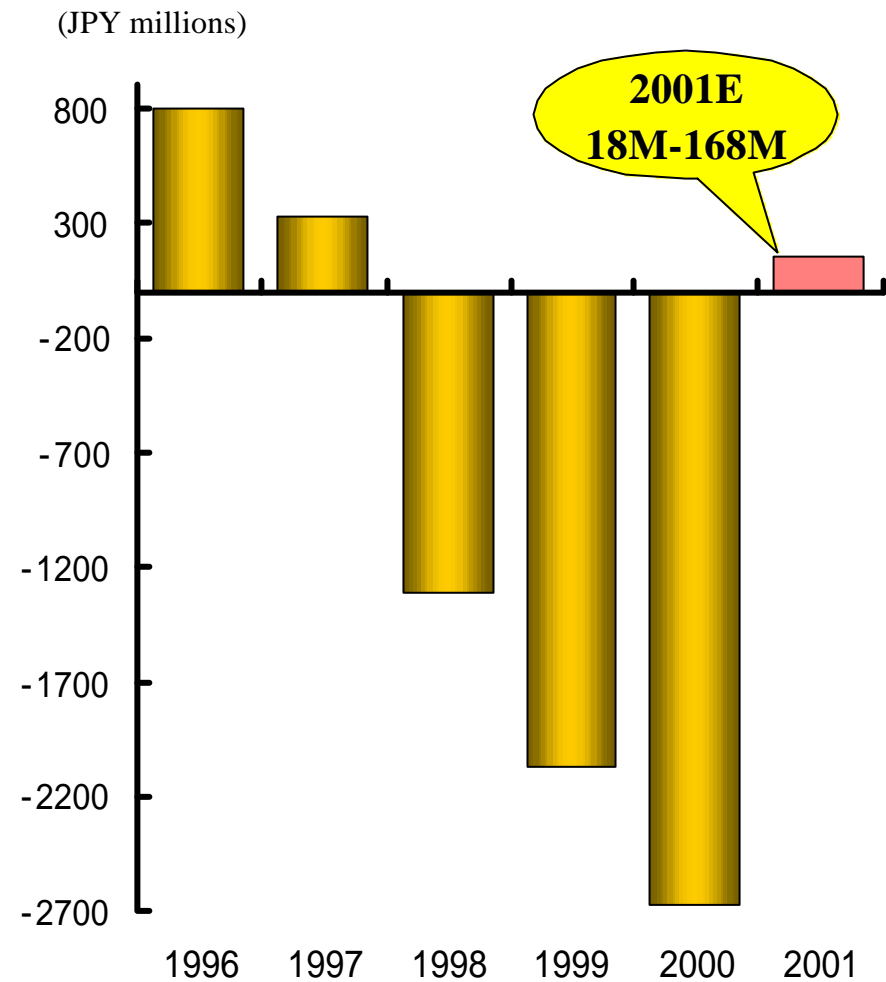

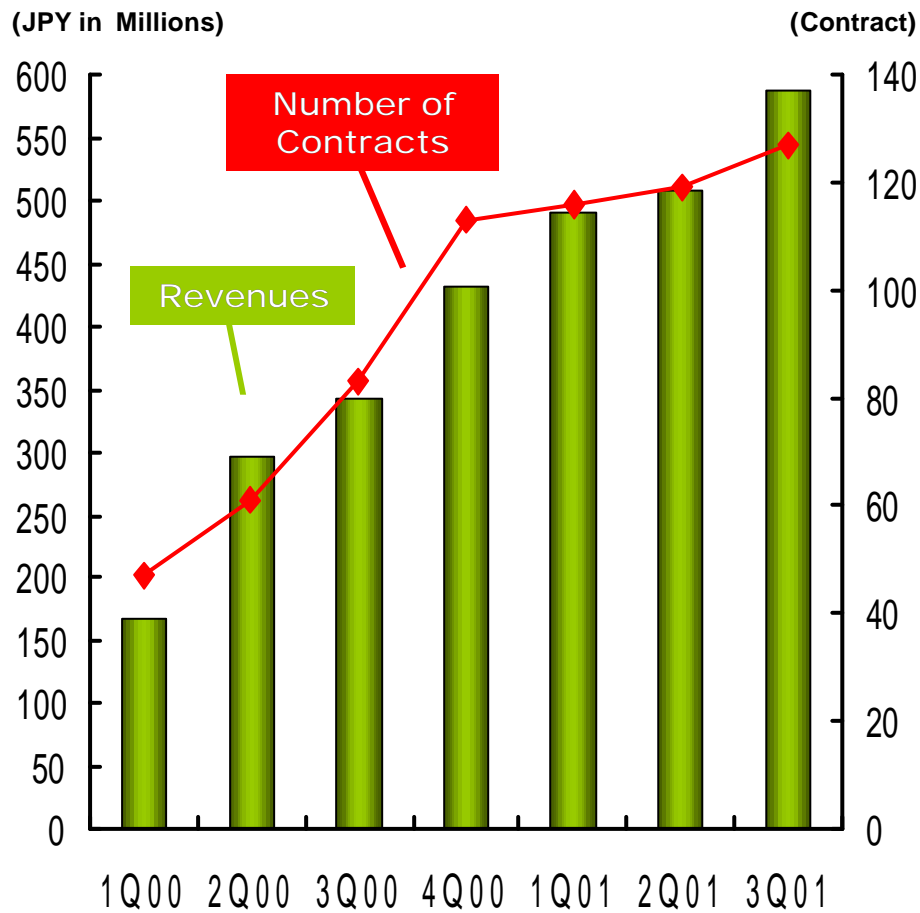
IP Service(*) ARPU

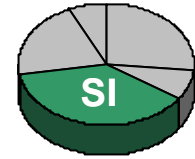




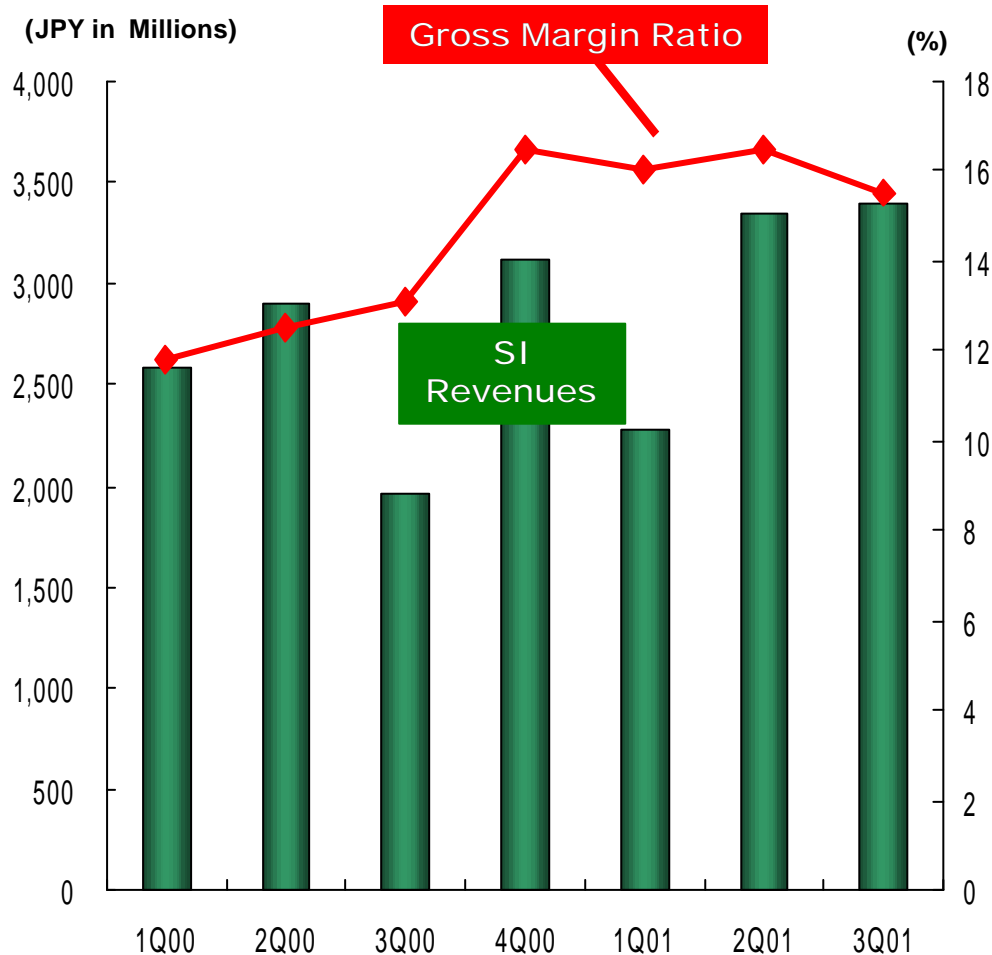
Revenues and Contracts

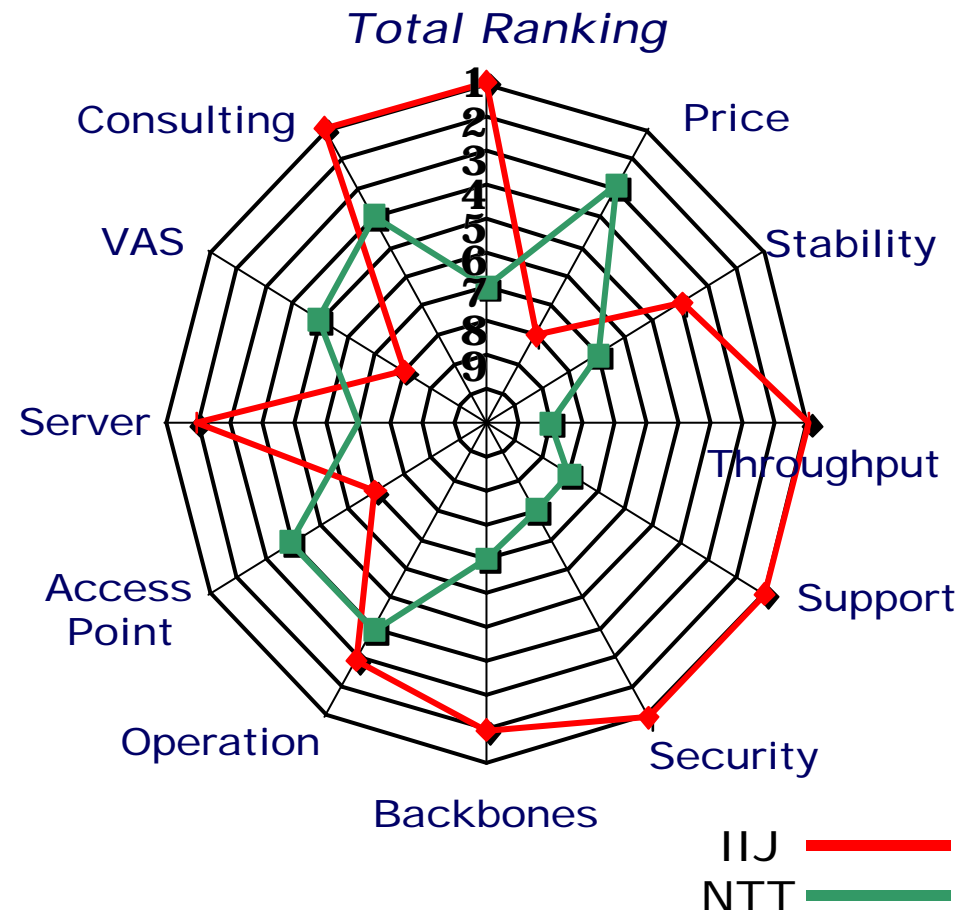

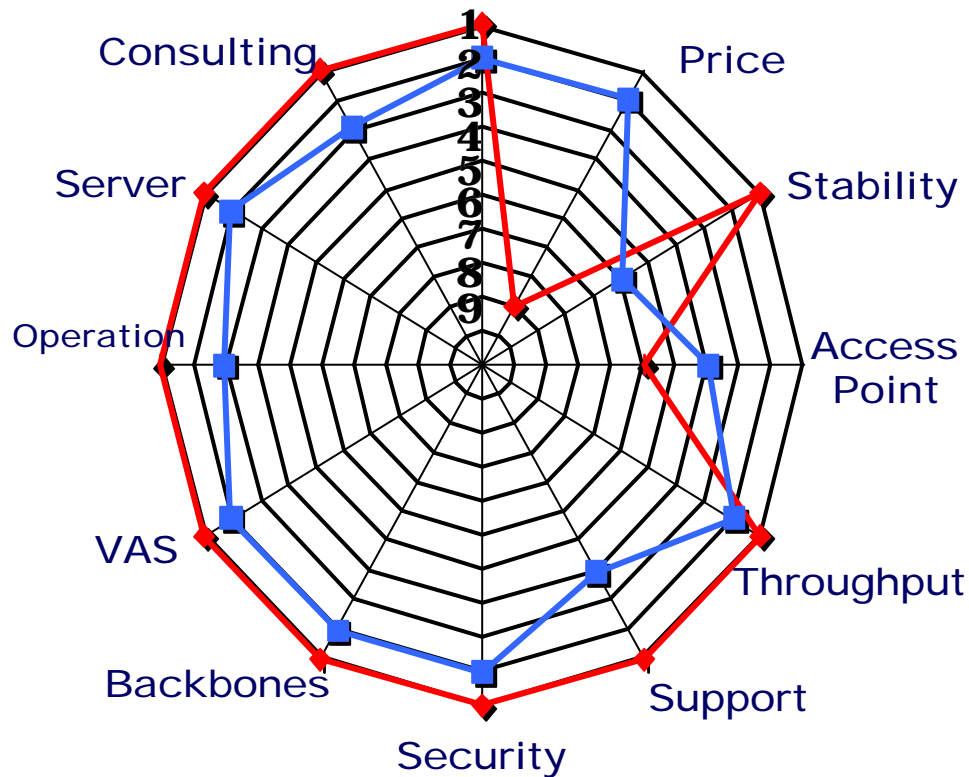

Total Ranking

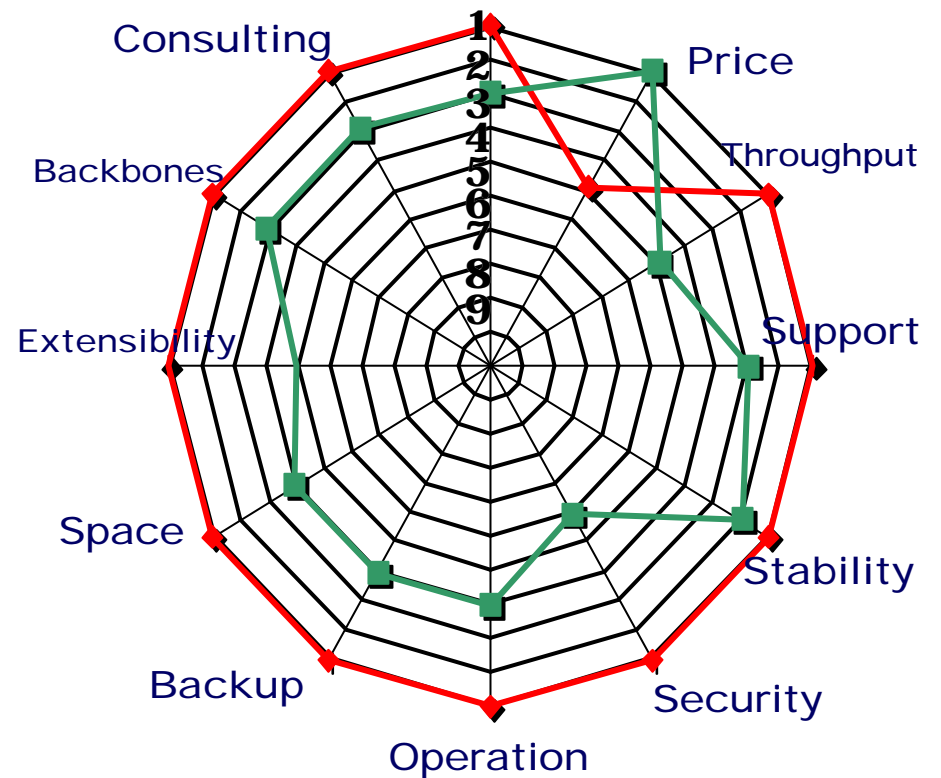


IIJ — (Red line)

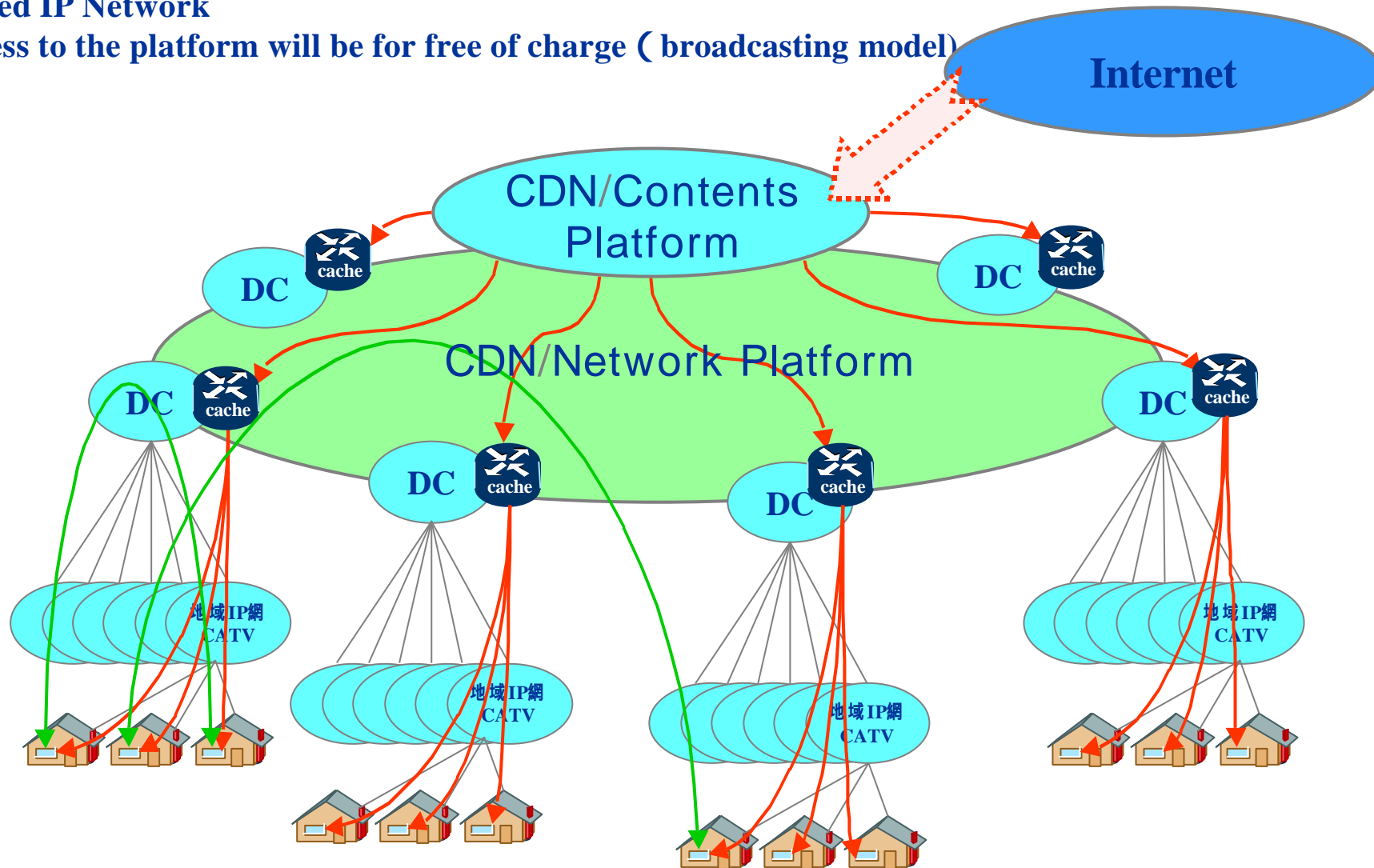

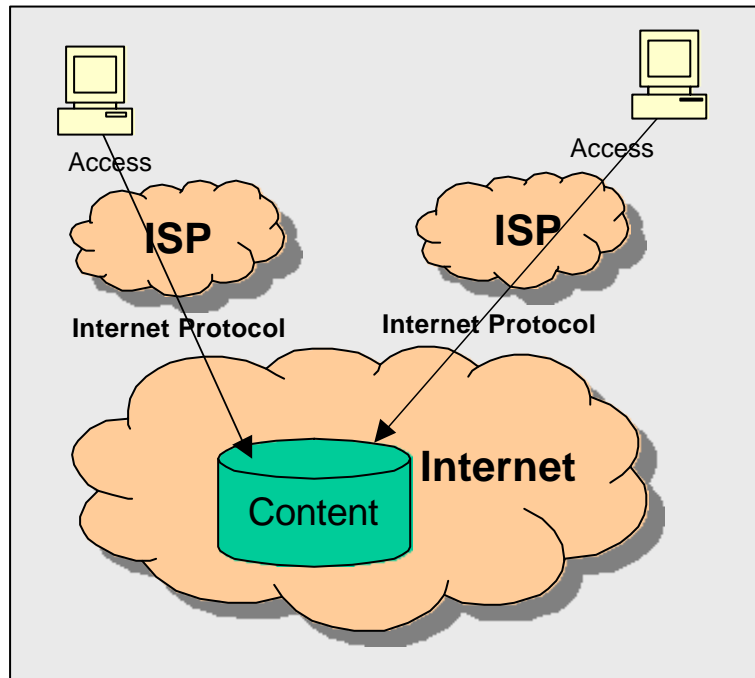

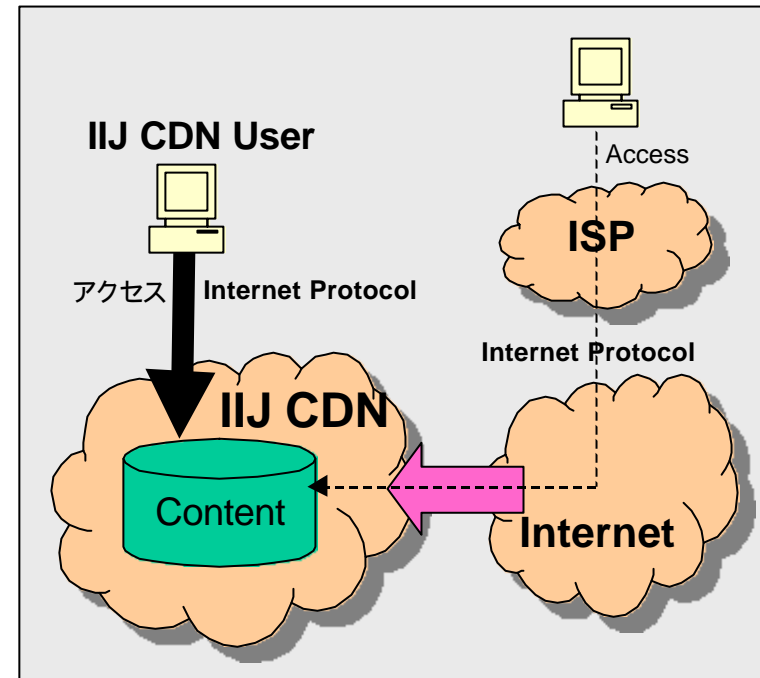
