IIJ to Increase Data Volumes in the IIJmio High-speed Mobile/D Service

-- Service to be enhanced for all fee plans, while monthly fees to remain unchanged; Family Plan greatly increased in volume from 7GB to 10GB per month --

TOKYO—March 10, 2015—Internet Initiative Japan Inc. (IIJ, NASDAQ: IIJI, TSE1: 3774), one of Japan's leading Internet access and comprehensive network solutions providers, today announced that it is enhancing its "IIJmio High-speed Mobile/D Service" for individuals. Starting April 1, 2015, IIJ will increase the data volumes for high-speed data transmissions, named "Bundle Coupons" in all fee plans.

The "IIJmio High-speed Mobile/D Service" offers a low-cost SIM card compatible with NTT DOCOMO's LTE and 3G networks. IIJ will enhance the high-speed data volume that will be distributed on the first day of every month, up to a maximum of 10GB (in the Family Share Plan)—without raising monthly fees. These increases will enable customers to enjoy IIJ's convenient mobile data communications services with even greater value for their money.
