The services in-scope of the management system are:

- ▶ IIJ Secure Web Gateway Service (Statement of Applicability for services provided by SEC management system version 1.1)
- ▶ IIJ DDoS Protection Service (Statement of Applicability for services provided by SEC management system version 1.1)
- ▶ IIJ Managed WAF Service (Statement of Applicability for services provided by SEC management system version 1.1)
